John A. Tuell, MA, is Director of the Child Welfare League of America (CWLA) Juvenile Justice Division. He oversees development of the work to bring a greater national awareness to the relationship between child maltreatment and juvenile delinquency, through such efforts as conference keynote and workshop presentations, development of publication materials, and building of state and local collaborations through public and private agencies, organizations, and political jurisdictions. Mr. Tuell previously served in the U.S. Department of Justice as Deputy Director of the State and Tribal Assistance Division in the Office of Juvenile Justice and Delinquency Prevention (OJJDP), providing managerial oversight to six grant programs. He joined OJJDP in December 1997 and served as Manager of the Comprehensive Strategy for Serious, Chronic, and Violent Offenders Initiative and the Juvenile Accountability Incentive Block Grant Program during his tenure. Mr. Tuell worked in the Fairfax County, Virginia, Juvenile and Domestic Relations District Court for 17 years in a variety of capacities, including field office probation supervisor, intake officer, and administrator at a residential facility for serious and chronic juvenile offenders. Mr. Tuell earned his Bachelor of Social Work degree from James Madison University and his Master of Arts degree in Criminal Justice from George Washington University.

Cathy Spatz Widom, PhD, is Professor of Psychiatry and University Professor, Department of Psychiatry, New Jersey Medical School, University of Medicine and Dentistry of New Jersey, Newark. A graduate of Cornell University with a BS in Child Development and Family Relationships, she holds MA and PhD degrees in Psychology from Brandeis University. She is a fellow of the American Psychological Association (Division 41—Law and Psychology) and the American Psychopathological Association.

A former faculty member in Psychology and Social Relations at Harvard University and in Criminal Justice and Psychology at Indiana University and the University at Albany, State University of New York, Dr. Widom has served on the editorial boards of psychology and criminology journals and is a frequent consultant on national review panels. Dr. Widom has received numerous awards for her research, including the 1989 American Association for the Advancement of Science Behavioral Science Research Prize, the ninth Mark Keller Award (1996), Distinguished Contribution to Applied Research in Psychology and Law from the American Association for Applied and Preventive Psychology (1997), and the Robert Chin Memorial Award from the Society for the Psychological Study of Social Issues (with Michael G. Maxfield). Since 1986, Dr. Widom has studied the long-term consequences of early childhood abuse and neglect, with a particular focus on the intergenerational transmission of violence. She serves on the Committee on Law and Justice at the Commission on Behavioral and Social Sciences at the National Research Council (NRC) and was Cochair of the NRC Panel on Juvenile Crime, Juvenile Justice.

Janet K. Wiig, JD, MSW, is Executive Director, Institute on Criminal Justice, University of Minnesota Law School. Ms. Wiig's career in public policy and program development spans more than 20 years of working in government agencies in the areas of juvenile justice, child welfare, and criminal justice. Ms. Wiig is recognized nationally for her pioneering work in the area of very young offenders. She was a member of OJJDP's study group on very young offenders and a chapter author for the book *Child Delinquents: Development, Intervention, and Service Needs* (Sage Publications). From 1992 to 1998, Ms. Wiig was Assistant Hennepin County Attorney in Minneapolis, Minnesota, working on special assignment to develop policies and programs in the areas of child welfare and juvenile justice. She directed a crime

prevention initiative based on her research on children under the age of 10 who have committed delinquent acts. From 1987 to 1992, she was Assistant Commissioner and Director of Children's Services with the Minnesota Department of Human Services. From 1979 to 1987, she held positions with the Los Angeles Juvenile Court overseeing policy and program development, and she was the founding director of the Child Advocate's Office. Ms. Wiig has served as an advisor, consultant, or board member to several national and state organizations including the National Council of Juvenile and Family Court Judges, ABA Center on Children and the Law, California Children's Lobby, Children's Law Center of Minnesota, and the New England Resource Center for Children and Families.
