In Illinois...

- There are 213, 465 children living in grandparent-headed households (6.6% of all children in the state). There are another 75,362 children living in households headed by other relatives (2.3% of all children in the state). Of the children living in households headed by grandparents or other relatives in Illinois, 119,676 are living there without either parent present.
- 103,717 grandparents report they are responsible for their grandchildren living with them [41,328 in Chicago and 1,576 in Rockford]: 41% of these grandparents are African American; 16% are Hispanic/Latino; 2% are Asian; and 39% are White. 28% of these grandparents live in households without the children's parents present. 76% are under the age of 60; 12% live in poverty.

Children in Foster Care

Numbers – September 2007

- 15,776 children in substitute care under supervision of Illinois Department of Children and Family Services (DCFS).
- Of these children, 6,031 were in kinship foster care.

Preferences

- Placements should be consistent with the best interest, safety and special needs of a child. This may include placement with relatives
- There is no separate licensing program for kinship foster parents. Relatives must meet the same licensing standards and receive the same foster care payment rate as non-kin foster parents. A relative can be a non-licensed foster parent if certain safety standards are met and can receive 100% of the “standard of need” payment. The “standard of need” payment is more than a TANF child-only grant, but is lower than a foster care board payment.
- Extended Family Support Program (EFSP) provides services to kinship care families through collaboration with the probate court, the Department of Public Aid, the State Central Register and the public schools. The focus of the program is short-term, home stabilization to help relatives provide quality care. The program provides a small cash allowance and assists families in obtaining guardianship, getting public aid and enrolling in school.

Subsidized guardianship

- Subsidy for children who have been transferred from DCFS’s custody to the guardianship of a relative caregiver. The subsidy rate is the same as the state’s foster care and adoption subsidy rates.
- Eligible children include children who are living with kin, have been living in the home of the caregiver for one year and have been in the DCFS system for one year. Children over age 12 not living with kin are also eligible. DCFS must rule out return home and adoption before a child is eligible for this program. This program is a special project supported by the federal government. Other criteria limit eligibility. Eligibility should be discussed with a child’s caseworker.

Public Benefits

Children are often eligible for state and federal benefits even if their caregivers do not have legal guardianship or custody. These programs include:

Financial Assistance

- Cash payments may be available to children who live with a relative through the Temporary Assistance for Needy Families (TANF) Program.

State Laws

Laws change and are subject to different interpretations. These general descriptions are not intended as legal advice in any particular situation.

Standby Guardianship

IL Rev. Stat Ch. 755 § 5/11a-3.1

- Allows a parent to designate a standby guardian to assume the day-to-day care of a child in the event of a parent's inability to function as a parent. It does not limit the rights of other living parents.

Grandparent Visitation Act

Public Act 94-1026

- Amends the Illinois Marriage and Dissolution of Marriage Act. Provides that grandparents, great-grandparents and siblings of a minor child may petition the court for visitation in the county in which the child resides if the custodial parent denies visitation and the other parent is deceased, missing for 3 months or more, incompetent as a matter of law, or incarcerated for 3 months; the parents are divorced or legally separated or there is a pending dissolution proceeding involving custody or visitation of the child.

Relative Placement Act

Public Act 94-0880

- Provides that the Department may place a child with a relative if it determines that the relative will be able to adequately provide for the child's safety and welfare and if the placement is consistent with the child's best interests.
- The Department shall make reasonable efforts to identify and locate a relative who is ready, willing, and able to care for the child and these efforts are to be renewed each time the child requires a placement change.

Tuition Assistance Act

Public Act 94-0968

- Amends the Higher Education Student Assistance Act to provide that a person is entitled to a renewable, \$1,000.00 grant for each year he or she is enrolled full-time at an institution of higher learning.
- Students must be in the legal custody of their grandparent, receive public assistance under the Illinois Public Aid Code, graduated from high school with a cumulative grade point average of at least a 2.7 on a 4.0 scale, and be recommended by their high school principal.
