Re: Vote YES on H.R. 494, The Tiffany Joslyn Juvenile Accountability Block Grant Program Reauthorization Act of 2019

Dear Representative,

On behalf of the National Juvenile Justice and Delinquency Prevention Coalition, we encourage you to vote "yes" on H.R. 494, the "Tiffany Joslyn Juvenile Accountability Block Grant Program Reauthorization Act of 2019." The National Juvenile Justice and Delinquency Prevention Coalition (NJJDPC) is a collaborative array of more than two hundred national and state youth-and family-serving, social justice, law enforcement, corrections, and faith-based organizations, working to ensure healthy families, build strong communities and improve public safety by promoting fair and effective policies, practices and programs for youth involved or at risk of becoming involved in the juvenile and criminal justice systems.

The Juvenile Accountability Block Grant (JABG) expired in 2013 and has gone unfunded ever since. The expiration of this block grant program has greatly limited states abilities to implement effective, age-appropriate accountability and prevention measures to ensure children receive needed services and that communities remain safe. As recently as Fiscal Year 2002, JABG was funded for \$250 million (more than \$350 million after adjusting for inflation). Though the new authorization is vastly smaller than the prior authorization, it still a critical investment for our states and deserves your support.

H.R. 494 updates the JABG to reflect current research and practices and incentivizes states to use graduated sanctions and incentives grounded in positive youth development, enhanced antibullying measures, gang prevention programs, and additional youth violence prevention and intervention services. It also updates the JABG to include evidence-based practices, such as trauma-informed practices and mental health care.

Federal support for juvenile justice programming has suffered greatly in the past decade, with funding decreasing by around 50% to the states.² Reauthorizing this important program, with

recommended funding levels of \$30 million annually for the next five years, would make a tremendous difference to youth, families, and communities.

We urge you to support reauthorization of this critical program and vote "yes" on H.R. 494.
